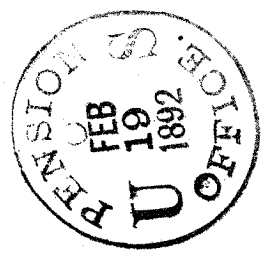

- The Act of June 27, 1890, REQUIRES, in case of a soldier:
1. An honorable discharge (but the certificate need not be filed unless called for).
 2. A minimum service of ninety days.
 3. A permanent physical disability not due to vicious habits. (It need not have originated in the service.)
 4. The rates under the act are graded from \$6 to \$12, proportioned to the degree of inability to earn a support, and are not affected by the rank held.
 5. A pensioner under prior laws may apply under this one, or a pensioner under this one may apply under other laws, but he cannot draw more than ONE pension for the same period.

Sir:

In response to your letter you are advised that your above cited claim for pension under the Act of June 27, 1890 stands rejected on the ground that you did not serve ninety days in the late Civil War. It appears that you were in the service only from June 27th to August 13, 1863. Pensions are allowed only as authorized by law, and there is apparently no law under which you can be pensioned.
